On Monday, April 17th, the Zumbrota-Mazeppa High School Choir participated in Singing for Life High School Choral Festival. This was a wonderful event at Bethel Lutheran Church in Rochester, MN with the Dover-Eyota and Kingsland high school choirs as well as the Rochester Choral Arts Ensemble and Cantus.

The Choral Arts Ensemble has been inspiring audiences throughout southeast Minnesota with performances of outstanding choral music since its founding by Rick Kvam in 1985. The auditioned singers of CAE are active community members from a wide variety of professions, including teachers, doctors, medical students, business people, computer technicians, and church leaders, all drawn together to create excellent music and contribute to the artistically

Cantus is a nationally recognized professional singing ensemble out of Minneapolis, MN. The "engaging" (New Yorker) low-voice ensemble Cantus is widely known for its trademark warmth and blend, innovative programming and riveting performances of music ranging from the Renaissance to the 21st century. The Washington Post has hailed the Cantus sound as having both "exalting finesse" and "expressive power" and refers to the "spontaneous grace" of its music making. The festival day consisted of members of Cantus working with our ZMHS Concert Choir on our set of songs, a vocal technique class for our HS choir, and learning a new round called "Love is Love is Love" by Abbie Betinis.

In the evening, we listened to the other high school choirs, the Chorale Arts Ensemble and Cantus. We performed "Three Madrigals" by Emma Lou Diemer and "Walkin' Down That Glory Road" arranged by Mark Hayes and then performed the round with all of the evening performers and the audience. Some ZMHS Choir students stated that they really enjoyed listening to adult choirs and singing with them in a huge circle in the sanctuary. "It was neat to know that we can keep singing even as adults." "It was a fun day." "Cantus helped us find words to emphasize so that we create a more meaningful vocal experience for the audience."

The fifth grade Math Masters competition was held in Rochester on Friday, April 21st. There were 149 top math students from twelve different schools around southeastern Minnesota vying for honors. The ten ZMES fifth grade students did very well with the fact drill section by taking home seven of the thirty awards given to the top scorers. Braelynn Rude and Hunter Jasperson won medallions with Brody Schulte, Olivia Chapin, Carson Dilley, Brantley Frederixon and Henry McCormick bring-



ing home ribbons. All ten of the ZMES students scored in the top third of all participants.

The competition then progressed to the story problem phase. The students had ten minutes to finish eight problems such as "The grocery store is having a 50% off sale on steaks. A quarter pound of steak is now \$2. What is the regular price for a half pound?".

(Ans \$8) After finishing four of these tests, the students then worked as a team of five to complete three similar tests but with more complex questions. There were 33 teams at the Rochester site with all students being the top math students from their school. The ZMES students had a great showing and a very challenging but enjoyable day.


#### **New Business:**

Tony went over the pros and cons of having a .75 vs. .4 Trainer. Tony Brown recommends a .75 Mayo Athletic Trainer costing \$43,680. He gave multiple ideas on how to offset the cost. Tony will look for more cost savings. This will be an action item on the May 8th work session agenda.
- 7. GCED Information: Mr. Harvey reports the Superintendent's of GCED are looking at ways to decrease the price of ALC programs and River Bluff Education Center and Tower View. They are looking to combine the programs, possibly adding on the River Bluff Education Center/GCED. More information will be coming on this.
- Jason Lohmann motioned to call for quotes for Lumber, Earthwork, HVAC and Plumbing quotes for the 2023-24 school construction house. Quotes due to the District office by 10 AM on May 19. Stephanie Miller second the motion. All in favor. Motion carried.
- Policy 516.5 Overdose Medication: Mr. Harvey asked the school board members to review this policy and recommends it be adopted over the summer after legislation acts.

- 3. 2024 Marching Band Trip: Scott Cory, Marching Band Director would like to take the Marching Band to Colorado July 1 6, 2024. He went over the itinerary and prices of the trip. This will be brought back to the May 22, 2023 School Board Meeting for approval. Mr. Cory was given permission to start talking to students about the trip.
- 4. 2025 Costa Rica Trip: Ashley Bucholz would like to take a group of students to Costa Rica and Panama during the summer of 2025. She went over the itinerary and prices. This will be brought back to the May 22, 2023 School Board Meeting for approval. Ms. Bucholz was given permission to hold an informational meeting on May 16th 2023.
- 5. FCCLA: Mae James and Kara Groby, FCCLA Member gave an overview of the service projects and awards FCCLA members have achieved this year. FCCLA and Leo Club work closely with the Lions clubs of Mazeppa and Zumbrota.
- 6. General Music Curriculum: Katrina Schuneman and Abby O'connor presented the QuaverED 4th-8th Grade Music Curriculum. There currently is not a curriculum for these grades. This is a web based curriculum that they would like to purchase for a 1

- year trial. This will be brought back to the May 22, 2023 meeting for approval.
- 7. LTFM Plan: Mr. Harvey reviewed the LTFM plan. This is a 10 year plan that has to be sent to MDE by June 30th. This will be brought back to the May 22, 2023 meeting for approval.
- 8. Discussion on District Property Parcel 23.00233.00 in Mazeppa: A resident is interested in purchasing this from the district. Mr. Harvey said the parcel is valued at \$130,000. School Board Members need to decide if the district is interested in selling the parcel and would have to go for bids. Discussion was had. Mr. Harvey will follow up with the resident to see if he would be interested in splitting the property and he will also look into how much a survey would cost.
- **9.** District Insurance Information: The Dental, Life and LTD is up for renewal. Last year a 2 year policy was taken out. No Action is needed.

### Item for Approval:

1. Athletic Trainer Contract: Tony Brown was asked at the last meeting to find funding sources for the Athletic trainer Contract. Mr. Brown looked at shuttle services, scoreboard revenue and raising athletic fees. The trainer will be available Monday - Friday, 3-6PM. Discussion was had. Jason Lohmann motioned to accept the athletic trainer contract. Stephanie Miller seconded the motion. Jason Lohman-yes, Jean Roth-yes, Stephanie Miller-Yes, Angie Bredehoft-No, Jake Rude-No, Travis Llffrig-No. Motion failed. Discussion was again had. Angie Bredehoft motioned to approve the athletic trainer contract at a .75 with the requirement that athletic fees will be reviewed in July. Jason Lohmann seconded the motion. All in favor.
